# PRIVACYPOLICY

This website belongs to and is run by Satim (referenced below as "Satim" or "We"). It is committed to protecting its user's privacy ("User" or "You"). This Privacy Policy explains our information gathering and dissemination practices with respect to the services provided by our website ("Services", "Website" or "Site").

# DATA AND PERSONAL INFORMATION WE COLLECT

When You use the Site, we may collect and\or receive information that may be considered personal in the course of your use of the Site, such as information about your laptop, tablet, mobile device and operating system, unique device identifier, software, your usage of the service, location data, time zone, browser type, Internet Protocol (IP) address, network Media Access Control (MAC), Cookies (as defined below), language preference, referring pages, exit pages and URLs, number of clicks, domain names, landing pages, pages viewed and the order of those pages, the amount of time spent on particular pages, the date and time of this activity, whether you open, forward or click-through emails and ads, log files, and other usage data including data and information received whenever You interact with Satim, or use the Services or Website. By analyzing all information we receive, we may compile statistical information across a variety of users ("Statistical Information"). For the purpose of analysis and statistics, provided that such disclosure is done anonymously and is non-personal identifiable;
